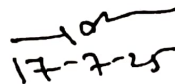

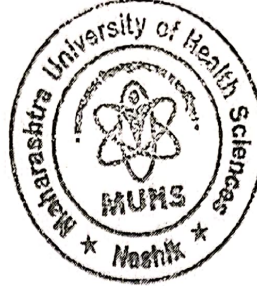

कोळपे नर्सिंग कॉलेज, मु. पो. कोळपेवाडी, ता. कोपरगाव, जि. अहमदनगर या संस्थेस सन २०२५-२६ साठी ५० (पन्नास) विद्यार्थी प्रवेश क्षमतेसह पी.बी.बी.एस्सी.(नर्सिंग) अभ्यासक्रम सुरु करण्यास पुढील अटी व शर्तीच्या अधीन राहून याद्वारे शासनाची मान्यता देण्यात येत आहे.

अटी व शर्ती :

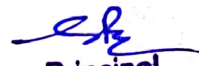
